AUDIT EXECUTIVE SUMMARY:

"Miedema Produce Inc" is an organization that processes, pack, and stores Radish, Carrots, Turnips, Parsnips, Radish Sprouts, Beets/Beetroot in Surprise, AZ. The audit was conducted in the processing operation that has 45000 feet² (facility size) approx. The operation runs product year-round with a workforce of 50 workers. The product flow basically is comprised of receiving, processing, packing, storage, and shipping. The process includes recirculated water steps with antimicrobials (CCP), single-pass steps with antimicrobials (only Carrots, Radish, Parsnip), and cutting the product with equipment or trimming if needed with knives (only Radish). The water source is a well, for all the water steps, except for the rinse step in the processing room (Radish), which uses city water. Recirculated water steps and metal detectors are considered CCPs. The audit was conducted in one day.
