### AUDIT EXECUTIVE SUMMARY:

This inspection and the total time spent included 6 farms (growing areas), one harvesting crew, and one processing facility. The Farming/ Harvesting evaluation included the review of the growing/ harvesting activities involved in the production of conventional fresh radishes, which includes the evaluation of the growing areas, the ground history & adjacent land use, the handling of chemicals -both for nutritional and pest control-, the quality of the water used for fertigation, irrigation, pesticides application and hand washing, the hygiene of the field workers and sanitary facilities. This Farm has approximately 52 Acres for the production of the radishes, in one single block: SL-1. The growing area this season was done as dryland farming. There is the gun river on the east sector of this farm that is the back up for irrigation and using the pivot overhead irrigation system when needed. There was observed some disking activities for the next plantings. The adjacent land for farming is used on a 4 to 5 year rotation between corn -4 seasons- and radishes -one season-. The whole growing area is surrounded by agriculture land in a rotation between 4 years with corn and 1 year with radishes, along woods areas a small river and main paved road. Season runs usually from May to October.
